

## ***RELEASE OF LIABILITY***

### ***READ CAREFULLY - THIS AFFECTS YOUR LEGAL RIGHTS***

In exchange for participation in the “Camp Carnage” activity produced by Treadway Events & Entertainment LLC., the undersigned participant agrees as follows and understands “Camp Carnage” will have actors and staff scaring, touching, kidnapping and tormenting Camp Carnage Campout attendees throughout the event. As a guest you may ingest food safe items, be handled, bound/chained, caged, hosed, pulled and/or pushed. This is all part of the theatrical experience and in no way are guests in any real danger whatsoever. As a matter of record, this event is organized by Treadway Events & Entertainment LLC., of 194 NE 187th Ave., Portland, Oregon, 97230 and/or use of the property, (leased, rented, or owned) or services of Treadway Events & Entertainment LLC. (hereinafter “facilities”), of Treadway Events & Entertainment LLC., I, \_\_\_\_\_ (Full Legal Name), of \_\_\_\_\_ (Street), \_\_\_\_\_ (City), \_\_\_\_\_ (State), agree for myself and (if applicable) for the minor aged members of my family participating, to the following:

**1. AGREEMENT TO FOLLOW DIRECTIONS.** I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Treadway Events & Entertainment LLC., or the employees, representatives or agents of Treadway Events & Entertainment LLC.

**2. ASSUMPTION OF THE RISKS AND RELEASE.** I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge Treadway Events & Entertainment LLC. for injury, loss or damage arising out of my or my family's use of or presence at the facilities whether caused by the fault of myself, my family, Treadway Events & Entertainment LLC. or other third parties.

**3. INDEMNIFICATION.** I agree to indemnify and defend Treadway Events & Entertainment LLC. against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the facilities of Treadway Events & Entertainment LLC.

**4. FEES.** I agree to pay for all damages to the facilities caused by any negligent, reckless, or willful actions by me or my family.

**5. APPLICABLE LAW.** Any legal or equitable claim that may arise from participation in the above shall be resolved under Oregon law.

**6. NO DURESS.** I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review it before signing. I further agree and acknowledge that I am free to have my own legal counsel review this Agreement if I so desire. I further agree and acknowledge that Treadway Events & Entertainment LLC. has offered to refund any fees I have paid to use its facilities if I choose not to sign this Agreement.

**7. ARM'S LENGTH AGREEMENT.** This Agreement and each of its terms are the product of an arm's length negotiation between the Parties. In the event any ambiguity is found to exist in the interpretation of this Agreement, or any of its provisions, the Parties, and each of them, explicitly reject the application of any legal or equitable rule of interpretation which would lead to a construction either "for" or "against" a particular party based upon their status as the drafter of a specific term, language, or provision giving rise to such ambiguity.

**8. ENFORCEABILITY.** The invalidity or unenforceability of any provision of this Agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any other provision of this Agreement or of any other applications of such provision, as the case may be, and such invalid or unenforceable provision shall be deemed not to be a part of this Agreement.

**9. DISPUTE RESOLUTION.** The parties will attempt to resolve any dispute arising out of or relating to this Agreement through friendly negotiations amongst the parties. If the matter is not resolved by negotiation, the parties will resolve the dispute using the below Alternative Dispute Resolution (ADR) procedure.

Any controversies or disputes arising out of or relating to this Agreement will be submitted to mediation in accordance with any statutory rules of mediation. If mediation does not successfully resolve the dispute, then the parties may proceed to seek an alternative form of resolution in accordance with any other rights and remedies afforded to them by law.
